Advisement of Potential for Repeated Rule Violations during Pending Investigations

However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

290-2-3-.19 Infant-Sleeping Safety Requirements(CR)

Finding Associated with Complaint

290-2-3-.19(1)(a)2 requires that a mattress shall be provided for each crib and other equipment approved for infant sleep and shall be firm, tight-fitting, at least two inches (2") thick and covered with waterproof, washable material. Before a change of occupant, each mattress shall be cleaned with a disinfectant. It was determined based on investigative findings that four mattresses in four pack-n-plays measured approximately one inch (1")

thick on this date not meeting the two inches (2") thick requirement on this date.

290-2-3-.13(1) requires that the Home be clean and free from hazards. It was determined based on investigative findings that the following items were not clean and in good repair on this date:

- In the kitchen the cabinets, stove and refrigerator were stained with dirt and food particles.
- The house smelled of animals and feces from a dog defecating in a cage during the time of the visit.
- The house appeared dark throughout at the time of the visit.
- The walls appeared to be stained throughout the house.
