 background clearance All staff members are required to have completed at least a national fingerprint based clearance check Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding

290-2-3-.04(2) (d) requires the family child care learning home to comply with all applicable laws and regulations. Georgia law (O.C.G.A. Sections 20-1A-4, 20-1A-10 and 20-1A-12) reguires a family child care learning home provider to pay an annual license fee in order for a license to be issued. Georgia law (O.C.G.A. Sections 20-1A-4, 20-1A-10 and 20-1A-12) requires that an annual license fee be paid for each family child care learning home registered by the Department. A review of records determined the total annual license fee for this family child care learning home was not paid by the due date of Dec 31, 2018.

POI (Plan of Improvement)
