- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. - Exposed black tarp was observed underneath the yellow and green swing set located on the middle right side of the playground creating a potential tripping hazard.
- An active ant mound was observed on the front right side of the playground next to the green and brown picnic table.
- Exposed tree roots were observed on the back-right side of the playground area creating a potential tripping hazard.
- A small active ant mound was observed on the back-right side of the playground area next to the exposed tree roots.
- Vines were observed growing through the fence located on the front right side of the playground.

POI (Plan of Improvement)

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure that the Home's outdoor play area is kept clean and free of hazards.
