It was determined based on review of records that one helper and one resident did not have evidence of a criminal records check letter on file on this date. A one day letter was left.

**POI (Plan of Improvement)**

IMMEDIATE CORRECTION - The Home will follow-up with the records unit to ensure that every Employee has a valid and current satisfactory Comprehensive Records Check Determination on file prior to being present at the Home while any child is present for care or before an individual age 17 or older resides in the Home. The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. The provider must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The Home will monitor the expiration dates of residents and helpers to ensure the CRC rules are maintained. Provider provided a comprehensive letter for the helper the following day.
