On this date, Consultant observed one (1) caregiver, the Provider, to be present with children in care.

March 11 2020, the system error incurred during the visit was resolved and the Consultant emailed a copy of the completed report to the Provider.

.13 (2) (d) Such outside play areas shall be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the department. Fencing material shall not present a hazard to children. A fence shall be provided around swimming pools to make them inaccessible when not in use. It was determined based on the consultant's observation that the fence gate that serves as the main entry to the children's playground measures approximately 2 feet and 8 inches in height. The fence gate needs to be four (4) feet or taller to serve as an adequate barrier. The consultant also observed that the left pole connected to the fence gate contained a gap in the lattice covering that measured approximately four inches wide, which posed as an entrapment hazard.
