It was determined based on consultants review of records that one child does not have no liability statement signed by parents in the file.

290-2-3-.08(9) requires that the Parent or person(s) authorized by the Parent or guardian to drop off and pick up the Child document each time the Parent or authorized person drops off and picks up the Child. The documentation shall include at least the following information: the date , the Child's name, the arrival and departure times, and the signature or initials of the Parent or authorized person and shall be made available to the Department in printed or written form upon request. It was determined based on consultants review of records that five children are present during the visit and only two children are signed in with required documentation, one child is missing the time of arrival, one child is missing the parent signature and one child is not signed in at all.

The Home will develop, if needed, and implement sign-in and out procedures that include all required information, will inform Parents of the procedures and will monitor to ensure Children are signed in and out as required.
