April 23, 2019: The investigation was closed on this date. Three rule violations were found. A copy of the report was sent to the provider.

If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Finding Associated with Complaint

290-2-3-.13(2)(d) requires that outside play areas be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the Department. Fencing material shall not present a hazard to children. A fence shall be provided around swimming pools to make them inaccessible when not in use. It was determined that on April 2, 2019, at 11:15 a.m. a four-year-old child was playing on the front porch that was not fenced. The porch led to the yard which had direct access to traffic as a road was in front of the facility in a residential neighborhood.

Finding Associated with Complaint

290-2-3-.14(1) requires the Home to report to the Department within twenty-four hours or the next work day: any death of a Child while in the care of the Home; any serious illness or injury requiring hospitalization or professional medical attention other than first aid administered by the Provider, Provisional Employee or Employee of the Home; any fire; any structural disaster; the closing of the Home and any situation when a Child in care becomes missing, such as, but not limited to, a Child who is left on a vehicle, a Child who leaves the building, playground, or property, or a Child who is left behind on any trip. It was determined that the provider did not report to the Department when a four-year-old child left the premises on April 2, 2019. The provider did not notify law enforcement after she searched for the child for approximately 45 minutes. The child was found at a convenient store by a witness.

The Home Provider will ensure a timely report is made to the Department as the licensing rules require.

290-2-3-.07(14) requires at least one Adult with a satisfactory Comprehensive Records Check Determination to supervise Children at all times and requires plans to be made to obtain additional adult help in cases of emergencies. It was determined that on April 2, 2019, at 11:15 a.m. a four-year-old child left the premises while playing outside on the front porch. It was reported that the provider was inside of the home or distracted when the child left the premises. The child was found by a witness at a convenient store approximately 0.1 miles away from the facility at 12:20 p.m.
