It was determined based on Consultant's observation, an infant was observed asleep in a portable crib that lacked a tight-fitting sheet.

## POI (Plan of Improvement)

The Home Provider will ensure that each crib or other equipment approved for infant sleep has a tight-fitting sheet that is changed daily or more often as needed and prior to a change of occupant. Provider will attend a training re: Infant safe sleeping and or SIDS and summit a copy of the certificate to consultant. A phone conference will also be scheduled.

To ensure the control of disease transmission, the Home Provider will change diapers in the child's crib or a non porous surface. The diapering surface will be cleaned and disinterred between use with a single use disposable towel. A non porous surface for diapering will be added.
