

The following information is associated with a Initial Licensing Study:

290-2-3-.12 Equipment and Supplies(CR)

Finding

290-2-3-.12(7) requires all indoor and outdoor furniture and equipment shall be secured if equipment and furniture is of a weight or mass that could cause injury from tipping, falling, or being pulled or pushed over. Potentially unstable equipment and furniture that might injure a child if not secured include, but are not limited to, televisions, chests of drawers, bookcases, shelving, cabinets and fish tanks. Examples of items not required to be secured include, but are not limited to, child-sized tables and chairs, rocking chairs, and cribs. It was determined, based on Consultant observation, that a water cooler, located in the outdoor play area, was not secured and posed a tipping hazard.

POI (Plan of Improvement)

The Provider stated that the Home will secure/attach the water cooler to a post located in the outdoor play area. The Provider also stated that the Home will ensure that all potentially dangerous equipment is maintained secure.

290-2-3-.19 Infant-Sleeping Safety Requirements(CR)

Comment

On this date, Consultant observed one (1) of one (1) play yard (pack 'n' play) that will be used for sleeping and resting, to meet Consumer Product Safety Commission (CPSC) and American Society for Testing and Materials International (ASTM) safety standards. Consultant also discussed all Infant Safe Sleeping and Resting requirements with the Provider, prior to the visit and on this date. Further, Consultant observed the correct number of cots, sheets and covers, and discussed cot disinfecting requirements with the Provider on this date.

Finding

290-2-3-.13(2)(d) requires that outside play areas be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the Department. Fencing material shall not present a hazard to children. A fence shall be provided around swimming pools to make them inaccessible when not in use. It was determined, based on Consultant observation, that the outdoor deck area that will be used for children's play, was enclosed with a fence that measured approximately three (3) feet, two (2) inches in height, rather than four (4) feet as required.

POI (Plan of Improvement)

The Provider stated that the Home will add Department - approved fencing to the outdoor play deck area that measures at least four (4) feet in height.

Comment

The Home was not operating and there were no children enrolled or present on this date. Consultant discussed proper hand washing of children and staff with the Provider, prior to the visit and on this date.

Consultant discussed with Provider to ensure that all areas of the diapering surface are completely non porous. The Provider stated that a new diapering pad was ordered, with a smooth, non - porous surface on all sides, and delivery expected within five (5) business days.

Consultant stated to Provider that prior to providing Transportation and/or Field Trips, the Home (Provider and/or Home Employee; if operating the vehicle) is required to maintain on the vehicle; a current driver's license, complete first - aid kit and fire extinguisher, emergency medical forms regarding each child being transported on the vehicle, and appropriate individual child safety restraints (seat belt, car seat, etc.), in accordance with current State and Federal laws. Consultant also stated to the Provider, that the Home is required to ensure that children are directly supervised on the vehicle by Staff at all times, and that all parental agreements regarding Transportation and Field Trips, are completed and maintained on file. Further, Consultant stated to the Provider that prior to providing Transportation and/or Field Trips, the Home is required to contact the assigned Bright from the Start: Regional Consultant, to discuss and review all Transportation and Field Trip Rules.
