290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on observation, the following hazards were observed:

The provider had steps leading to the outdoor play area with four and a half (4.5) inch gaps at the railing, and six and a half (6.5) inch openings under each step posing an entrapment hazard.

Adjacent to the bottom step an exposed stone posing an hazard.

POI (Plan of Improvement)

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure the outdoor play area is kept clean and free of hazards. The provider will add netting to the railing, wood to cover each step opening, and add protective covering over the stone to prevent a hazard.
