

- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Finding

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on consultant's observation the following hazards were observed on the playground posing a hazard to the children in care.

- * Car not in working condition
- * Shed with a gap measuring six inches under the bottom of the shed.
- * Gutter sprout not covered
- * Trash cans

POI (Plan of Improvement)

The Home will remove the car from the yard or place a four (4) feet barrier around it. Provider will add lattice on the bottom of the storage unit. Provider will add rubber sprout on the bottom of the gutter sprout. Provider will also add a four (4) feet barrier around the trash cans or remove them from the playground area. Provider will check the playground regularly to ensure all hazardous items are removed daily before the children goes out to play.
