- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

It was determined based on observation that cement was exposed at the bottom of the fence posts along the back of the playground. Additionally, a cord was not secured to the home.

POI (Plan of Improvement)

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure that the Home's outdoor play area is kept clean and free of hazards.

Discussed adding a sturdy board along the bottom of the fence to ensure that there is not a gap more than 3 1/2 inch gap from fence to ground.
