- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

It was determined based on consultant's observation that hazards existed in that there were several exposed light bulbs over the hand washing sink in the bathroom, the closet housing the hot water heater lacked a lock and the black refrigerator on the main level lacked a safety strap to prevent the children from having access. Consultant also observed a staple gun, staples and a hole puncher accessible in the area that will be serving the children. The items were removed during the visit.

To ensure the safe storage of hazardous items, the Home Provider will make these items inaccessible to the children.
