- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

**Comment**

On this date, Consultant observed one (1) of one (1) Play yard, used for sleeping and resting, to meet Consumer Product Safety Commission (CPSC) and American Society for Testing and Materials International (ASTM) safety standards. Consultant also discussed all Infant Safe Sleeping and Resting requirements with Provider, prior to the visit and on this date. Further, Consultant observed the correct number of mats and discussed mat disinfecting requirements with Provider on this date. The provider currently has mats that are less than two-inch thick and will double them up until able to purchase new mats.

**Comment**

On this date, the Provider stated that the program will not participate in Swimming activities. Consultant discussed Swimming requirements with the Provider, prior to the visit and on this date. **Finding**

290-2-3-.13(2)(d) requires that outside play areas be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the Department. Fencing material shall not present a hazard to children. A fence shall be provided around swimming pools to make them inaccessible when not in use. It was determined based on consultant's observation and measurements that there was an eight inch gap between the fence and the house wall, and a four-inch gap at the bottom of the fence gate. Additionally, it was determined that the gaps between the front porch railing measured between six and eight inches and were posing an entrapment hazard.

The Home will enclose cover the gaps with mesh, wood or other approved material.

Consultant discussed to that an assistant, who must be at least sixteen (16) years of age, must be present to assist with supervision whenever more than three (3) children under the age of twelve (12) months are present, more than six (6) children under the age of three (3) years are present or more than eight (8) children under the age of five (5) years are present.
