- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

- Exposed tree roots.
- Air condition unit lacked a barrier.
- -Sharp rock protruding out of the ground accessible to children.
- Uneven surfacing between the hard and soft surface creating a tripping hazards.
- Six inch gap on both side of barrier near the wooden fence.

POI (Plan of Improvement)

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure that the Homes outdoor play area is kept clean and free of hazards.
