Permission to Operate issued on this date. Provider has Liabiliy Insurance. Zoning limits the capacity to five (5) children at any given time. An Administrative Review was conducted on October 21, 2020. Staff files, children's files, training, and background checks were all reviewed. An in person Initial Licensing Study was conducted on October 23, 2020. The exit conference was conducted in person on this date at 11:30 a.m. with the Provider. Compliance with the Executive Order issued on August 18, 2020 was reviewed during the inspection and discussed during the exit conference. Consultant discussed the new rules and regulations with the Provider on this date.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

You have received permission to operate and the form received with this report is intended to serve as a temporary license which is <u>valid for thirty(30) days</u>. ## Finding

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on observation that the climbing wall on the left side of the slide had two (2) deteriorated panels of wood.

## POI (Plan of Improvement)

The Home will replace the panels and regularly check the structure to ensure that it is safe for children.

## **Finding**

290-2-3-.13(2)(c) requires that climbing and swinging equipment that are not portable have a resilient surface beneath the equipment and the fall zone from such equipment, which is adequately maintained by the Home to assure continuing resiliency. It was determined based on observation that the slide and swing set lacked resilient surface. Consultant measured one (1) inch of resilient surface beneath and within the fall zones. Around the slide, three (3) inches of resilient surface is required within the fall zone of six (6) feet out. Around the swing, six (6) inches of resilient surface is required within fourteen (14) feet in front of and fourteen (14) feet behind, and six (6) out each side of the swing.

## POI (Plan of Improvement)

The Home will ensure that there is an adequate resilient surface under and in the fall zone of climbing and swinging equipment.
