- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Such records shall include: identifying information (Child's name, birth date, Parent's name, home and business addresses, telephone numbers); name, address and telephone number of persons, including Child's physician, to contact in emergencies; and name, address, telephone numbers, relationship to Child and to Parent(s) and other identifying information of person(s) to whom the Child may be released. It was determined based on observation during the review of (2) two of (2) two files lacked the following:

- -Child #1 lacked release person information, parent work number and address.
- Child #2 application lacked physician information and immunization record.

- Office supplies such as scissors, permanent markers and gem clips were accessible on the provider desk.
- Toilet brush and trash can lacked a liner in the bathroom.

To ensure the cleanliness and safety of the environment, the Home Provider will make hazardous items inaccessible to the children. All items were removed during the visit. A trash liner was added to the trash can.

Finding

290-2-3-.13(2)(d) requires that outside play areas be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the Department. Fencing material shall not present a hazard to children. It was determined based on observation the barrier measured at three feet ten inches instead of the required four feet in height. Consultant also observed a four to seven inch gap at the right and left bottom of the barrier.

POI (Plan of Improvement)

The Home will enclose the outside play area(s) with a four-foot high fence or other Department-approved barrier and inspect regularly to ensure fencing material is safe and any hazards identified are repaired or replaced. The Provider plan to enclosed the area with a permanent chain-link and or wooden fence.
