### Finding

It was determined based on a review of records that three of the six records reviewed did not have a copy of the no liability acknowledgement in the record as required.

It was determined on this date based upon the consultant's observation that the following potential hazards existed on the playground:

- The tongue on the caterpillar tunnel was broken and cracked in three places presenting a potential entrapment and scratching hazard.
- The cover on the turtle sand box was split on one side posing a potential pinching hazard.

To ensure the health and safety of children, the Home Provider will repair or remove the pieces of broken equipment.
