An Administrative Review was conducted on May 21, 2020. Staff files, children's files, training, and background checks were all reviewed. A virtual inspection was conducted on June 19, 2020 with the Provider. An in-person visit was not conducted due to the COVID-19 pandemic. Compliance with the Executive Order issued on June 11, 2020 was reviewed during the virtual inspection.

Plan of Improvement: No Plan Developed

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. The consultant observed that the provider had 6.5 hours of training completed January 4th and 5th of 2020. The consultant explained to the provider that annual training is reviewed at every licensing study. The consultant explained that providers have from January to December to complete their training for the year. The consultant explained that when reviewing the training, the consultant looks at the previous year of training; therefore, in order for the training to count, it has to be dated within the twelve months of the year being reviewed. The provider had an incident that occurred in June of 2019 and the provider had to close her program until the end of November of 2019. The consultant explained that the provider would be cited at the next licensing study if the provider did not complete 10 hours within the next year.
