- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. 290-2-3-.12(5) requires all indoor and outdoor furniture, activity materials, and equipment shall be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint and kept clean. It was determined based on observations that the plastic covering the outdoor swing chains were cracked. The plastic on the chains had area with sharp plastic edges and space where the children fingers could be pinched. In addition there was rust on the swing set metal frame.

POI (Plan of Improvement)

The Home will repair or replace the swing chains. The provider will make the swings inaccessible to the children until the chains are repaired. The Home will monitor all indoor and outdoor equipment to ensure it is free from hazards and kept clean.

No Home personnel shall impede in any way the delivery of emergency care or services to a child by licensed or certified emergency health care professionals. It was determined based on observation and discussion that the home did not have he required emergency preparedness plans on file.

It was determined based on observation that there was not an adequate amount of sand in the fall zones of the swings. The sand measured between one and three inches in depth however six inches is required.

POI (Plan of Improvement)

The Home will ensure that there is an adequate resilient surface under and in the fall zone of climbing and swinging equipment. The Home will inspect equipment and resilient surfacing material regularly and repair or replenish as needed.
