An Administrative Review was conducted on June 3, 2022. Staff files, children's files, training, and background checks were all reviewed. An in person Complaint Investigation/Initial Licensing Study was conducted on June 8, 2022. Permission to operate was not granted on this date due to the director needing to submit the certificate of occupancy. Once certificate of occupancy is obtained, director can email it consultant and PTO can be granted from the desk. Facility does not carry Liability Insurance. The facility has a capacity limitation of 147 due to the playground capacity of 49. The director provided the certificate of occupancy on June 13, 2022. Permission to Operate issued on June 13, 2022.

Plan of Improvement: No Plan Developed

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee
