- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





### Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

#### **Finding**

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined there were four blue benches throughout the playground areas which posed as potential hazards in that they were not free of rust and chipped paint as required. Additionally, four swings and two bucket seats on the front of the playground and six swings on the back of the playground had rusted "O" and "S" hooks which connected the swings together with rusted chain links. The bucket seats also had rusted triangular parts that were connected to the bucket seats.

### POI (Plan of Improvement)

The Center will provide a variety of age-appropriate equipment that is arranged so as not to obstruct supervision of children. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters. The center will repair or replace the benches.

#### Recited on 8/25/2022

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation there was approximately four inches of mulch surrounding the red, blue and yellow climbing structure with the yellow slide connected. There was approximately two inches of mulch surrounding the blue and yellow monkey bars and the yellow and green climbing structure with the three slides connected.

### **POI** (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency.

#### **Technical Assistance**

Please ensure the playground is free from hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete, etc. Consultant discussed with the director to ensure tree roots were sprayed, the mat was level to the ground or removed and the fencing was free of rust spots as required.
