- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Finding

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined that the following hazards were present:

- * In the third left classroom, adult scissors, plastic bags, lysol wipes, baby wipes and butt paste which were labeled, "keep out of reach of children" were present in an unlocked cabinet under the diaper changing table.
- * In the fourth left and fifth left classrooms, baby wipes, labeled, "keep out of reach of children" were observed in an unlocked cabinet under the diaper changing table.
- * In the fourth left classroom, microband spray, labeled, "keep out of reach of children" was located on top of the cubby area. Additionally, hanging cords were surround the computer monitor which was accessible to children in care.
- * In the second left classroom, a toilet brush was observed in the bathroom accessible to children in care.
- * In the third right classroom, an unlocked closet contained a staff member's purse, accessible to children in care.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

Correction Deadline: 4/1/2022

Finding

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined that the following were not in good repair:

- * In the first right classroom, the boarders surrounding the back walls were detached from the wall and chipped paint was observed throughout the walls of the classroom.
- * In the second left classroom, the boarders surrounding the walls in the bathroom were detached from the wall.
- * In the fourth left classroom, the boarders surrounding the left back wall were detached from the wall.

POI (Plan of Improvement)

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.

591-1-1-.33(3) requires each Staff member with direct care responsibilities to complete health and safety orientation training within the first 90 days of employment. The state-approved training hours obtained will count toward required first year training hours. The training must address the following health and safety topics: prevention and control of infectious diseases (including immunizations); prevention of sudden infant death syndrome and use of safe sleeping practices; administration of medication, consistent with standards for parental consent; prevention of and response to emergencies due to food and allergic reactions; building and physical premises safety, including identification of and protection from hazards that can cause bodily injury such as electrical hazards, bodies of water, and vehicular traffic; prevention of shaken baby syndrome, abusive head trauma and child maltreatment; emergency preparedness and response planning for emergencies resulting from a natural disaster or a human-caused event (such as violence at a child care facility); handling and storage of hazardous materials and the appropriate disposal of bio contaminants; precautions in transporting children; recognition and reporting of child abuse and neglect; and child development. It was determined one staff member did not complete the 10 Hour Health and Safety training within 90 days of employment as required.

POI (Plan of Improvement)

The Center will develop and implement a plan to schedule and track this training for all employees based on their hire dates and will ensure that the training includes all required components as required.

Staffing and Supervision

Finding

591-1-1-.32(1) requires the Center to maintain the required Staff:child ratios as follows: under 1 year or under 18 months if not walking = 1:6; 1 year and walking = 1:8; 2 years = 1:10; 3 years = 1:15; 4 years = 1:18; 5 years = 1:20; and 6 years and older = 1:25. A Center must establish groupings of children for care with maximum group sizes as follows: under 1 year = 12; under 18 months/not walking = 12; 1 year and walking = 16; 2 years = 20; 3 years = 30; 4 years = 36; 5 years = 40; and 6 years and older = 50. It was determined the center did not maintain appropriate staff:child ratios in that the second left, two-year-old classroom had a staff:child ratio of 1:11 instead of 1:10. Additionally, the fifth left, two-year-old classroom had a staff:child ratio of 1:10 which was required.

POI (Plan of Improvement)

The Center will hire additional Staff or reschedule current Staff to meet required Staff:child ratios and will organize children into groups that meet requirements.
