- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

Finding

591-1-1-25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined the following hazards were present:

- * Vaseline, labeled, "Keep out of reach of children" was present in an unlocked drawer in the second left classroom.
- * Baby wipes labeled as a suffocation hazard were present on a low shelf in the children's bathroom in the third left classroom.
- * A first aid kit with items labeled, "Keep out of reach of children" was hanging beside the entry way of the door to the Pre-k 4A classroom.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

Finding

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on observation the following were not in good repair as required:

- * Ceiling tiles were buckled and discolored due to leaks in the roof in the second left, third left, Pre-k 4A. Pre-k 4B. Pre-k 4C, third right, fourth right, and fifth right classrooms. Additionally, ceiling tiles were also buckled and discolored in the children's bathrooms in the third right girl's, fifth right girl's, and Pre-k 4B girl's bathroom.
- * The diaper changing rail had chipped paint on the railing in the second left classroom.
- * The cabinet was detached from hinge in the third left classroom.
- * Chipped paint and splintered wood was present on the boarders in the third left, Pre-k 4A, Pre-k 4B, Pre-k 4C. fourth right and fifth right classrooms.

POI (Plan of Improvement)

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.

Finding

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observation the following equipment was not free of hazards as required:

- * Playground B The basketball net was missing.
- * Playground C Rusted "O" hooks were present at the top of the swings and throughout the links which connected the swings.
- * Playground D The shaded area was missing which covered the bucket seats. The stationary red tunnel, blue car, and yellow tunnel had chipped paint and rust present.

POI (Plan of Improvement)

The Center will provide a variety of age-appropriate equipment that is arranged so as not to obstruct supervision of children. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters.
