However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.12 Equipment & Toys(CR)

Finding Associated with Complaint

591-1-1-.12(1) requires each Employee and child in attendance to use all indoor and outdoor furniture, activity materials, and equipment in a safe and appropriate manner and in accordance with the manufacturer's instructions, recommendations, and intended use. All equipment and furniture shall be used only by the age-appropriate group of children. It was determined based on investigative findings that the center did not use high chair booster seats in accordance with the manufacturer's instructions and intended use. On undetermined dates between September 2022 and October 2022, center staff confined a two-year-old child and a three-year-old child to high chair booster seats which were placed on the floor or outdoor ground as a form of discipline. The two-year-old child, who was confined to the high chair booster seat, fell over in the booster seat and was not immediately placed in an upright position.

POI (Plan of Improvement)

The Center will ensure Staff are trained in and children are taught the proper use of all furniture, materials and equipment; will implement a plan for this information to be reviewed with both groups on an ongoing basis; and for monitoring proper and age-appropriate usage.

Health and Hygiene

591-1-1-.17 Hygiene(CR)

Finding Associated with Complaint

591-1-1-.17(2) requires that Personnel, to the extent possible, keep children clean, dry and comfortable. It was determined based on investigative findings that two, two-year-old children and a three-year-old child were not keep comfortable when they were confined to high chair booster seats for approximately 5-15 minutes. While in the high chair booster seats they screamed and cried to get out and after tipping themselves over, staff did not intervene.

POI (Plan of Improvement)

The Center will train staff, review regularly, and monitor.

Finding Associated with Complaint

591-1-1-.11(1) requires that disciplinary actions used to correct a child's behavior, guidance techniques and any activities in which the children participate or observe at the Center shall not be detrimental to the physical or mental health of any child. It was determined based on investigative findings that on undetermined dates between September 2022 and October 2022, center staff confined two two-year-old children to high chair booster seats on the playground for approximately 5 minutes. Also, on other various dates in September 2022 and October 2022, a three-year-old child was confined to a high chair booster seat as a form of discipline for approximately 15 minutes.

POI (Plan of Improvement)

Center staff will cease use of this disciplinary method; the director will provide staff training on appropriate child guidance techniques and have a system in place to monitor and identify/prevent inappropriate actions.
