- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

#### **Finding**

591-1-Ī-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observation of the playgrounds, the red play house on the back playground was observed broken. The back wall was no longer attached at the bottom and could be pushed out posing a finger entrapment hazard.

### POI (Plan of Improvement)

The Center will provide a variety of age-appropriate equipment that is arranged so as not to obstruct supervision of children. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters.

#### **Finding**

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on a observations of the playgrounds, large ant beds were observed on three of the five playgrounds.

#### **POI (Plan of Improvement)**

The Center will remove any litter and fix or remove hazards from the playground and will routinely monitor the playground and remove litter and hazards.

It was determined based on the consultant's review of records that the center did not submit evidence of parental authorizations for 10 of 12 children transported during the last two weeks of routine school transportation.

## **Finding**

591-1-1-.36(7)(b) requires that an emergency medical information record be maintained in the vehicle for each child being transported. The emergency medical information record for each child shall include a listing of the child's full name, date of birth, allergies, special medical needs and conditions, current prescribed medications that the child is required to take on a daily basis for a chronic condition, the name and telephone number of the child's doctor, the local medical facility that the Center uses in the area where the Center is located and the telephone numbers where the Parents can be reached. It was determined based on the consultant's review of records that the center did not submit evidence of emergency medical records for 10 out of 12 children who were transported during the last two weeks of school transportation.

#### POI (Plan of Improvement)

The Center will obtain a complete emergency medical information record for each child that is transported and maintain a copy on the vehicle.

#### Finding

591-1-1-.32(2) requires the Center maintain Staff:child ratios in mixed-age groups based on the age of the youngest group of children that includes more than twenty percent of the total number of children in the mixed-age group. It was determined based on observation that the following ratios were observed during nap time.

In the Main B, a ratio of 1:11 during nap was observed. There were 10 one-year-olds and one (1) two-year-old. A ratio of 1:8 was observed.

In Building II, R3, a ratio of 1:14 was observed during nap time. There were seven (7) one-year-olds and seven (7) two-year-olds which required a ratio of 1:8.

In Building II, R4, a ratio of 1:12 was observed during nap time. There were five (5) two-year-olds and seven (7) three-year-olds which required a ratio of 1:10.

## POI (Plan of Improvement)

The Center will provide adequate staff when there is a mixed-age group.
