Comments

The administrative review was completed on 04-27-2021 and the virtual visit was completed on 04-30-2021. The center director stated no medication is administered, no field trips or routine transportation is provided. The center has a total of 10 staff members in whch 6 are new staff hired since the consultant's last visit. One newly hired staff member has been employed since April 12, 2021 and has no satisfactory comprehensive criminal records check on file. A one-day letter, affidavid, script and plan of improvement was left with two assistant director's.

Plan of Improvement: To Be Submitted 05/10/2021

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important New Deadlines:

Due to the ongoing COVID restrictions, the deadline to become Quality Rated for programs who want to continue to receive Childcare and Parent Services (CAPS), has been extended to at least December 31, 2021.
