- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Finding

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on observation that the following hazards were present on the

- ---Two 5 inch and one inch crack was present on the brown playform of the brown, red and green gym set.
- ---The yellow, blue, green Little Tykes small climber was observed to have a crack across the top of the red slide. The crack had been taped and the tape was observed to be coming off, leaving the crack as a potential cutting hazard and the top part of the slide to cave in.
- ---One pink and yellow tricycle had tassells on the handlebars which pose as a choking hazard.
- ---One of five Little Tikes Coupe cars had a gas cap missing which had been taped. However, the tape was half removed leaving a gap for a child to stick their finger posing as a potential entrapment and cutting hazard.

POI (Plan of Improvement)

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure that the Home's outdoor play area is kept clean and free of hazards.
