An in person visit was done on this day to complete a Licensing Study. The provider stated she begin re-enrolling children in August of 2021 and reports having 4 full time children, 2 after school children and 6 drop in children if she has spots available for the day. The provider stated there has not been any household member changes and she has not hired any new staff. The provider stated no medication is administered, no field trips or routine transportation is provided.

- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





#### **Important New Deadlines:**

Due to the ongoing COVID restrictions, the deadline to become Quality Rated for programs who want to continue to receive Childcare and Parent Services (CAPS), has been extended to at least December 31, 2021.
