Technical Assistance

Consultant discussed monitoring toys, equipment, and furniture for normal wear and tear.

Finding

591-1-1.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined based on observation that the following toys and/or equipment were in need of repair:

- Classroom E-2R - A white two drawer plastic bin containing stacking cups and waffle blocks was observed to be broken and contained jagged edges.

- Classroom F-3R - The red clock hands were broken and four out of six black knobs were missing from the children's play stove. The sink sprayer was missing from the children's play sink. A red measuring cup stored underneath the sink contained a broken handle and jagged edges. All three items were housed in the home living area located the back-right side of the classroom next to the handwashing sink.

- Classroom G-4R - The sink faucet and the sink sprayer was missing from the children's play sink located in the home living area on the back-right side of the classroom.

- Classroom Back - The water sprayer was missing and the black plastic sink was broken, contained a crack, and was covered in tape in the children's sink located in the home living area on the back-middle side of the classroom.

POI (Plan of Improvement)

The Center will ensure that equipment and furniture are used by the age-appropriate group of children. The center will also ensure to replace and/or repair all broken equipment and/or toys notated and monitor equipment and/or toys for normal wear and tear.

Consultant discussed monitoring restroom vents for normal wear and tear and potential dust build-up.

Finding

591-1-1-.06(4) requires a Center first licensed after March 1, 1991, and Centers that remodel or add to existing plumbing facilities, to have the bathroom area fully enclosed and ventilated to the outside of the building with either an open screened window or functioning exhaust fan and duct system and requires Centers without fully enclosed bathrooms to ensure there is adequate ventilation to control odors and adequate sanitation measures to prevent the spread of contagious diseases. It was determined based on observation the following restroom ventilation systems were inoperable:

- The second left restroom ventilation was inoperable in the Cafeteria.
- The second right restroom ventilation was inoperable in classroom E-2R.

POI (Plan of Improvement)

The Center will fully enclose and ventilate bathroom areas, as required, and will provide adequate ventilation and sanitation in bathrooms that are not fully enclosed.

- Classroom G-4R - A bottle of "Simple Truth Organic Body Lotion" was stored in the children's cubby area located on the front-right side of the classroom.

- Classroom F-3R - Two bottles of shaving cream and "Sharpie" permanent markers were stored in a gray unlocked cabinet located on the back-left side of the classroom.

- Cafeteria - A tape dispenser containing sharp edges and a pair of adult size scissors were stored in a white five drawer plastic bin located on the front-left entry of the classroom.

- The consultant did not observe any children to handle the items during the visit.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observation that the red water table bin was broken and not secured to the tan base of the table located on the back-right side of playground C. Rust was observed in the corners of the tan handle bars and tan climbing ladders of the large sliding structure located on front-left side of playground Left Rear. The brown stairs covering was observed to be peeling on the tan sliding structure located on the front-left side of playground Left Rear.

POI (Plan of Improvement)

The Center will provide a variety of age-appropriate equipment that is arranged so as not to obstruct supervision of children. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters.

Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that the playground was not kept free of hazards as the following hazards were observed: - Two unwrapped garden hoses (green and black) were observed on the ground and accessible to children located at the front-left playground exit for classroom G-4R creating a potential tripping hazard.

- A silver, black, and yellow water sprinkler base was hanging from the fence next to the red and tan water table located on the back-right side of playground C.

- A six and a half (6 1/2) tear exposing two silver bolts in the playground turf was observed on the back-right side creating a hole measuring approximately two-inches in depth on playground C. The tear and hole created a potential tripping hazard.

POI (Plan of Improvement)

The Center will remove any litter and fix or remove hazards from the playground and will routinely monitor the playground and remove litter and hazards. The center will ensure to remove the sprinkler head from playground C, the garden hoses from classroom G-4R's playground exit, and repair the tear in the turf located on playground C.
