- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

Finding 591-1-125(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on observation that the following items were in need of being repaired or cleaned throughout the center:
Kitchen, 2nd Right Room- floor tiles were broken. Dirt and debris was around the baseboards of the classrooms and kitchen. Pre-K Room -behind the boys' toilet there was a hole, exposed rust, and tile was missing off of the wall. Afterschool Room-blue rubber was coming off of the wall near the left side of the door. 1st Left Room- toilet bolts on the bottom of the boys' toilet were exposed and greater than two threads. 4th Left Room- one of four toilets were not in working order, floor tiles were broken, and an exposed power strip located on the shelf near the television.

It was determined based on a review of records that the following were observed to be missing from emergency medical authorizations:

- -13 of 57 were missing the address of the medical facility.
- -One of 57 were missing the doctor's phone number.
- -Three of 57 were missing if the child had any allergies.
- -Seven of 57 were missing the father's name and contact information.
- -10 of 57 were missing a work phone number.
- -Two of 57 were missing if the child was on any medication.
- -Two of 57 were missing if the child had any special conditions.
