If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.26 Playgrounds(CR)	Not Met

Finding Associated with Complaint

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on staff statements and consultant's observation on May 5, 2022, the black mesh was observed to be torn in multiple areas and coming apart from the outside fence, causing a potential hazard.

POI (Plan of Improvement)

The center director observed these areas and will ensure they are corrected and stay fastened and in tact.

591-1-1-.32 Staff:Child Ratios and Group Size(CR)	Not Met

Finding Associated with Complaint

591-1-1-.32(4) requires that children under three years old be housed in separate physical areas from older children and cannot be mixed with older children except at specified times and circumstances. It was determined based on staff statements, children under the age of three are housed with older children for lunchtime which does not fall under the first or last hour of each day.

POI (Plan of Improvement)

The Center will find a way to keep children separate in times other than the first hour and the last hour of the day.
