If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.



Please refer to the website, <http://www.dec.al.ga.gov/CCS/RulesAndRegulations.aspx>, for information regarding October 1, 2018 rule changes about Criminal Records Checks that may affect your facility. In summary,

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. - 3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding Associated with Complaint

591-1-1-.17(12) requires that children's wet or soiled clothing be stored in individual plastic bags immediately after being removed from the child. Wet/soiled clothing was not stored as required. It was determined based on staff statements and face to face interviews, that the allegation that in late November 2022, center staff in the two-year-old classroom gave a parent soiled clothes that had not been placed in a plastic bag and had discarded the child's underwear after they were soiled. Investigative findings revealed that a parent was given soiled clothing that had not been placed in a plastic bag and the child's underwear had been discarded after it was heavily soiled. Investigative findings further revealed that the staff member was new to the center and was not clear about the procedure to be followed. Subsequently, new staff members were trained in the correct procedure to be followed, and now follow the center's procedure of rinsing soiled clothes, before placing them into a plastic bag to be handed to the parent. Due to a preponderance of evidence this allegation was substantiated.

POI (Plan of Improvement)

The center will provide instruction to staff regarding the sanitary storage of items.
