- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

You have received permission to operate and the form received with this report is intended to serve as a temporary license which is **valid for thirty(30) days**. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

591-1-1-.36(4)(b) requires that the interior of a transportation vehicle be clean, in safe repair and free of hazardous items, objects and/or other non-essential items which could cause injury. It was determined based on observation that the following hazards were identified on the transportation vehicles:

- White Van (Tag #CSU9149): Holes were observed near the bottom of the seats facing the aisle in the first, second, and third rows, posing a safety hazard.
- Yellow Bus (Tag #RWD1789): The left-side first-row seat was torn, exposing the yellow cushion. Additionally, the right-side second-row seat had damage near the bottom exposing green cushion, along with a hole near the upper back right area, all of which pose safety hazards.
- White Van (Tag #SGT0115): This vehicle was not in use on the date of observation. The previous citation repairs discussed during the visit conducted on September 22, 2025, must be completed prior to use. These include addressing tape-covered holes on the driver's seat, passenger seat, and the first, second, and third row seats.

The center will maintain that all transportation vehicles are clean, in safe repair, and free from hazards.
