- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Technical Assistance

The consultant discussed with the Provider that all composites on a playground that are four feet or higher require resilient surfacing. The composite on the playground was more than four feet and was without resilient surfacing and the consultant advised the provider that the composite could not be used until the resilient material was added. The Provider covered the composite and advised it wouldn't be accessible until the resilient surfacing was completed.

Correction Deadline: 8/9/2025

Finding

591-1-1.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that the watering system running had hoses on the ground and surround the playground causing a tripping hazard.

POI (Plan of Improvement)

The Center owner advised that they would raise the pipes off the ground and secure it to the fence.

Food Service

591-1-1-.15 Food Service & Nutrition**Met****Comment**

The Center is requiring the families to provide lunch daily and the center provides the snack. The consultant reminded the provider to send parents information on acceptable lunch options and that all lunches and snacks must meet USDA guidelines.

Health and Hygiene

591-1-1-.10 Diapering Areas & Practices(CR)**Not Met****Comment**

Staff stated proper procedures. Sinks with warm running water observed adjacent to proper diapering surfaces in all classrooms approved for diapering.

Finding

591-1-1-.10(1) requires Centers first licensed after March 1, 1991, and Centers that are renovated after March 1, 1991, to provide ventilation in the diapering areas with functioning exhaust fans and a duct system or by the required amount of window space provided by operable windows when open. It was determined based on observation that the diapering room did not have ventilation and the window space didn't have a screen.

POI (Plan of Improvement)

The owner will have a screen put on the window as well as have an exhaust fan added to the room.
