591-1-1-.32(4)(b) allows children who turn three years old during the regular school year to remain with two year olds for the remainder of the school year but requires agreement from the older child's Parent(s) for the continued placement. It was determined based on observation that in Room Left Rear there were five two-year olds and six three-year-olds. None of the children present had parent permissions to mix the age group.
