- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee



Important New Deadlines:

Due to the ongoing COVID restrictions, the deadline to become Quality Rated for programs who want to continue to receive Childcare and Parent Services (CAPS), has been extended to at least December 31, 2021.

It was determined based on a review of records that the following arrival and departure information was missing:

- On October 4, 2021, five out of 64 children present were signed in and out and no arrival or departure times were documented on the record.
- On October 5, 2021, six out of 68 children present were signed in and out and no arrival or departure times were documented on the record.
- On October 6, 2021, ten out of 68 children present were signed in and out and no arrival or departure times were documented on the record.
- On October 7, 2021, nine out of 68 children present were signed in and out and no arrival or departure times were documented on the record.
- On October 8, 2021, nine out of 68 children present were signed in and out and no arrival or departure times were documented on the record.
- On October 11, 2021, sixteen out of 68 children present were signed in and out and no arrival or departure times were documented on the record.
- On October 12, 2021, seven out of 68 children present were signed in and out and no arrival or departure times were documented on the record.
