Comments

An Administrative Review was conducted on December 18, 2023. Staff files, children's files, training, and background checks were all reviewed. An in person Initial Licensing Study was conducted on December 27, 2023. The exit conference was conducted virtually on December 27, 2023 at 2:30 p.m. with the Provider. Permission to operate was issued on this date. Facility does carry Liability Insurance. Based on Playground capacity the center is limited to 72. Measurements were taken for additional playground space but is not in use.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

You have received permission to operate and the form received with this report is intended to serve as a temporary license which is **valid for thirty(30) days**. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. Important Quality Rated/CAPS Update:

Activities and Equipment

591-1-1-.12 Equipment & Toys(CR)

Finding

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined based on the consultant's observation that the chairs in all classrooms except for the infant and one year old classrooms have rust on and around the foot.

POI (Plan of Improvement)

The Center will ensure that equipment and furniture are used by the age-appropriate group of children.

Technical Assistance

The consultant advised the provider that it is a requirement that the Center Staff provide table space for each child who is able to sit at a table unassisted and an appropriately sized chair or bench for each child who is not an infant and who is able to use a chair or bench.

The consultant advised the provider to have all ventilation rechecked in all classrooms.

Licensed capacity observed to be routinely met by center. The overall licensed capacity is 72 children based on playground capacity.

591-1-1-.25 Physical Plant - Safe Environment(CR)**Not Met****Finding**

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on the consultant's observation that in the bathrooms of the Pre-K, two-year old, and after-school classrooms were missing the screws on the base of the toilets.

POI (Plan of Improvement)

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.

591-1-1-.26 Playgrounds(CR)**Not Met****Finding**

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on the consultant's observation that the fence opening straight out of the door to the playground had an opening of 3.5 inches and on the fence opening on the right of the playground at the bottom had a gap measuring 4.00 inches causing an entrapment. Also the fence had rust on the top of it on the left side as you walk out on the playground.

POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use.

Health and Hygiene

Staff stated proper procedures. Sinks with warm running water observed adjacent to proper diapering surfaces in all classrooms approved for diapering.

There were no children present on this date. The center's discipline policy was reviewed on this date. Regulations regarding proper discipline were discussed with the director on this date.

Consultant observed Six (6) of six (6) cribs meeting safety compliance with Consumer Product Safety Commission (CPSC) and American Society of Testing and Materials International (ASTM) safety standards manufactured in 2022. Center requests to keep the capacity at the maximum capacity in the event of an overflow. Consultant discussed safe sleeping requirements with the Provider during the inspection visit.
