- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Finding

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observations that the purple and teal swing set was not anchored as required. It was further determined that the wooden barrier around the green and brown play structure was splintered and rusted nails exposed.

POI (Plan of Improvement)

The Center will move the teal and purple swing set the appropriate distance from the fence and will anchor the set as required, The Center will also remove and replace the barrier around the green and brown play structure. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters.
