An Administrative Review was conducted on July 26, 2022. Staff files, training, and background checks were all reviewed. An in person Initial Licensing Study was conducted on July 27, 2022. The exit conference was conducted virtually on July 28, 2022 with the Director. Permission to Operate was not issued on this date. Facility does carry Liability Insurance. Capacity is limited to 18 per zoning.

The program did not receive Permission to Operate on July 27, 2022 due to corrections needed. Once the corrections are made, the program will receive permission to operate.

The required corrections were made on August 1, 2022. The program was granted permission to operate on August 1, 2022.

Plan of Improvement: No Plan Developed

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee



Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.
