Please refer to the website, <http://www.decal.ga.gov/CCS/RulesAndRegulations.aspx>, for information regarding October 1, 2018 rule changes about Criminal Records Checks that may affect your facility. In summary,

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. Refutation Process:

You have the right to refute any of the citations noted in this report with which you disagree. To refute a citation(s), do the following:

- 1) Log into DECAL KOALA www.decalkoala.com with the userid for your program
- 2) On the home page scroll down to the Inspection Reports and select 'Refute Citation' for the visit report in dispute
- 3) Select the specific rule number(s) that you are refuting, add the reason for disagreement regarding the rule citation, and upload supporting documentation
- 4) Submit the refutation in DECAL KOALA to Child Care Services (CCS) within 10 business days of the completion date.

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding Associated with Complaint

591-1-1-.03(9) requires center staff to refrain from engaging in, or allowing children or other adults to engage in, activities that could be detrimental to a child's health or well-being, such as but not limited to, horse play, rough play, wrestling, and picking up a child in a manner that could cause injury. It was determined based on an investigation which included staff statements, interviews, documentation and video footage that this rule was cited. On July 11, 2024, at 1:48 p.m., a three-year-old child was injured by a staff member while in the classroom. Video footage showed that a staff member handled a child roughly when they placed their hand underneath the left armpit of the child, and slightly pushed the child backwards. The child stopped and the staff member grabbed the child by upper portion of the right arm, lifted the child, and the child went down to the floor on their knees. The staff member then lifted the child up by the upper right arm at the elbow. The child stood up and the staff member grabbed the child's right wrist. The staff member then grabbed the child by both arms, lifted the child and placed the child on the cot. The child sat on the cot and their right arm appeared to limp. The child attempted to stand, then went face down on their cot. The child sat up, held their right arm, and cried. The staff member looked down at the child as the child slid from the cot onto the floor. The staff member consoled the child and looked at the child's arm. The parents were notified, and the child was transported to a medical facility. Professional medical attention was required.

Health and Hygiene

Finding Associated with Complaint

591-1-1-.07(2) requires that Parents be immediately notified and specific instructions obtained until the child can be picked up or returned to the group, immediately when professional medical attention is required, or when the child experiences symptoms of moderate discomfort, or when the child is involved in an incident that puts their health and/or safety at risk and to notify Parents by the end of the day when professional medical attention is not required, when the child experiences symptoms of less than moderate discomfort or when the child experiences an adverse reaction to prescribed medication which does not constitute moderate discomfort. It was determined based on an investigation that on July 11, 2024, center staff did not thoroughly assess a three-year-old child for an arm injury after the child showed signs of moderate pain. While in the classroom, the three-year-old child was lifted by the upper right arm and elbow by the staff member. Staff provided comfort and a band-aid to the elbow of the child. The child was taken to a medical facility by the parents and diagnosed with Nursemaid's elbow of the right arm. Professional medical attention was required.
