- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. It was determined based on observation the HVAC system accessible to the children enroute to the playground and high grass on the play area.

POI (Plan of Improvement)

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure that the Home's outdoor play area is kept clean and free of hazards. The HVAC system will be enclosed with a four feet barrier. The grass will be cut.

Fencing material shall not present a hazard to children. It was determined based on observation the bottom of the surrounding fencing unattached at the bottom creating gaps and exposed screws on the fence gate and corner poles..

POI (Plan of Improvement)

The Home will enclose the outside play area(s) with a four-foot high fence or other Department-approved barrier and inspect regularly to ensure fencing material is safe and any hazards identified are repaired or replaced. Poles and or pegs will be added to the bottom of the fencing to secure it to the ground to enclosed gaps. Exposed screws will be cut back two threads and or capped.
