- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

(O.C.G.A. Section 20-1A-4)

The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. It was determined based on a review of records that staff #1 who was present with a ratio of 2:10 6-year-olds and up, had a satisfactory Comprehensive Records Check that had a portability period that ended on October 14, 2024, and expires on October 13, 2028.

The program's owner or an officer/member of the corporation must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The center will follow the procedures presented in the training videos to ensure the CRC rules are maintained.

It was determined based on a review of records that staff #2 had a satisfactory Comprehensive Records Check that was portable until October 8, 2026, and expires on October 7, 2030. Staff #2 was present with a ratio of 2:10 6-year-olds and up.

The program's owner or an officer/member of the corporation must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date.
