- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

290-2-3-.13(2)(d) requires that outside play areas be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the Department. Fencing material shall not present a hazard to children. It was determined based on consultant observation the gate opening to the playground fence had gap spacings exceeding 3.5 inches, which poses as a potential entrapment hazard.

POI (Plan of Improvement)

The home will add a wood slab in between the open spaces on the gate opening and inspect the wire material regularly to ensure fencing material is safe and any hazards identified are repaired or replaced.

Staff state proper knowledge of hand washing and hygiene procedures.

290-2-3-.11(1)(f) requires diapers to be changed in the Child's own crib or on a nonporous surface which is cleaned with a disinfectant and dried with a single use disposable towel after each diaper change. It was determined based on consultant observation that the provider did not have a changing table or a nonporous surface available to conduct proper diapering procedures.

POI (Plan of Improvement)

To ensure the control of disease transmission, the Home Provider will change diapers in the child's crib or a nonporous surface. The diapering surface will be cleaned and disinfected between use with a single use disposable towel.
