Further, from time to time the department discovers additional rule violations during the course of an investigation. If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding Associated with Complaint

591-1-1-.17(2) requires that Personnel, to the extent possible, keep children clean, dry and comfortable. It was determined based on staff statements and interviews that the allegation of on October 13, 2022, center staff failed to keep a four-year-old child, clean, dry and comfortable when it was stated that the child was picked up from the center with urine that leaked through the child's pants and a soiled diaper, while in the three and four-year-old classroom is substantiated. There is a preponderance of evidence to support the allegation. Staff statements revealed that on October 13, 2022, the center staff did not change the diaper of a four-year-old child as needed due to the four-year-old child not being in a diapering classroom. Staff statements further revealed that staff in the child's classroom were not made aware of the four-year-old child needing to have their diaper changed and would have done so sooner if they were made aware of the child's needs.

Correction Deadline: 10/18/2022

Staffing and Supervision

591-1-1-.32(2) requires the Center maintain Staff:child ratios in mixed-age groups based on the age of the youngest group of children that includes more than twenty percent of the total number of children in the mixed-age group. It was determined based on an investigation that on October 13, 2022, the center failed to maintain staff:child ratios for mixed ages. Consultant reviewed the attendance sheet for October 13, 2022 and observed 9 three-year-old and 22 four-year-old children present with one staff member. When the child:staff ratios of 2:31 is required.
