- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

It was determined based on investigative findings that the two-year-old restroom toilet seat was unstable due to is missing a screw and was in need of repair.
