- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

It was determined based on a review of records that two out of five immunizations records were expired and were not kept current as required.

- A green vacuum cleaner was stored in the child care area accessible to children.
- A vacuum was stored in the child restroom accessible to children.
- Three dog pee pads were stored on the floor in the child care accessible to children and read "Keep out of reach of children."

It was determined based on observation that a small white dog was observed in the child care area around five enrolled children throughout the entire visit and was not housed separately from the children as required.
