 - Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
 - Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on Consultant's observation that the front right side of the fence and the right corner area of the fence measured three (3) feet when four (4) feet is required. The Consultants also observed two eight inch gaps underneath the entrance gates to the playground. Rust was also observed on the entire fence. The side right of the fence towards the back of the playground had approximately three to four inch gap at the bottom of the fence with soft sand underneath that can easily be dug up by children in care.
