# Finding

591-1-1-.03(1) requires the Center to provide a daily planned program of varied and developmentally appropriate activities to promote social, emotional, physical, cognitive, language and literacy growth. Center Staff shall use a variety of teaching methods to accommodate the needs of the children's different learning styles.

It was determined based on consultant's observation, that there was not a planned program of varied activities available for the school aged children. On this date, the children played with their own electronic devices without interaction from the staff person.

# POI (Plan of Improvement)

The Center will plan a program that includes a variety of developmentally appropriate activities that are provided daily, train Staff to use various teaching methods, and monitor both.

It was determined based on an observation of children's records that an enrollment application was not available for each enrolled child. Seven records were requested. Three siblings were listed on one application which lacked individual information. That application also lacked the parent's work telephone number, allergy information and doctor's name and telephone number. Applications for two children were not available.

Center staff will develop a plan that includes how to obtain all required information for currently enrolled children and how to ensure this is done for future enrollees as well. The plan will also include how and where to maintain files for the required amount of time. The plan will be implemented and followed.

It was determined by consultant's observation that the ceiling vent in the main hallway was coated with dust/dirt. There was an exposed missing light switch plate in the alcove off the main hallway. There was a wagon with trash in it in the alcove off the main hallway. There was a hole in the ceiling in the hallway near the office with exposed wiring.

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.

An explanation shall be documented in writing whenever a child is transported to a field trip site but is not present on the return trip to the Center.

It was determined based on a review of transportation paperwork that on November 18, 2021, six school aged children were dropped off at the center from routine school transportation. The transportation checklist only accounted for three children.

# POI (Plan of Improvement)

The driver/other designated person will immediately document in writing with a check/mark/symbol each time a child gets on and off the vehicle.

Correction Deadline: 11/19/2021

#### Finding

591-1-1-.36(7)(d)2. requires that the second designated Staff person conduct a check of the vehicle immediately upon the completion of the first check of the vehicle. The responsible person shall physically walk through the entire vehicle; visually inspect all seat surfaces, under all seats and in all compartments or recesses in the vehicle's interior; and sign the passenger transportation checklist(s), indicating all of the children have exited the vehicle. There shall be continuous watchful oversight of the vehicle between the first check and second check.

It was determined based on observation that on November 18, 2021, the designated staff person did not conduct a second check of the vehicle once the children exited. The staff person signed the passenger checklist noting that a second check was completed.

# POI (Plan of Improvement)

The Center will train Staff who are or may be involved in transporting children in how to thoroughly inspect a vehicle and properly complete transportation documentation. The Center will review and monitor.

Staffing and Supervision

# **Finding**

591-1-1-.32(7) requires that children be supervised at all times appropriate to the individual age, needs and capabilities of each child. Such supervision must include, but not be limited to, indoor and outdoor activities, mealtimes, naptime, transportation, field trips, and transitions between activities. "Supervision" means that the appropriate number of Staff members are physically present in the area where children are being cared for and are providing watchful oversight to the children, volunteers and Students-in-Training. The persons supervising in the child care area must be alert, positioned to maximize their ability to hear and see the children at all times, and able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the volunteers and Students-in-Training, and provide timely attention to the children's actions and needs. Staff shall be attentive and participating with all children during mealtimes and shall be seated within an arm's length away from children thirty-six (36) months of age and younger.

It was determined that during the visit conducted on this date that children were not adequately supervised. The staff person in the infant/toddler classroom left the room on multiple occasions to go to the restroom and kitchen. The school aged children were observed to leave the lower classroom and come upstairs on multiple occasions. The six school aged children who were dropped off by the center van were not escorted into the center or delivered to a staff person.

# POI (Plan of Improvement)

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
