It was determined based on observation that children younger than three (3) years were grouped with older children at a time other than the first and last hour of operation in the 2nd right classroom.

The persons supervising in the child care area must be alert, positioned to maximize their ability to hear and see the children at all times, and able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the volunteers and Students-in-Training, and provide timely attention to the children's actions and needs. Staff shall be attentive and participating with all children during mealtimes and shall be seated within an arm's length away from children thirty-six (36) months of age and younger. It was determined based on observation that children in the 2nd right classroom were left unsupervised while the staff member opened the door for the Consultant.

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
